Agenda Item 7 – State Adopting Agency Rulemakings for the 2022 Intervening Code Adoption Cycle: CBSC will take action to approve, disapprove, or return for amendment with recommended changes, based on the proceedings by which the Board of State and Community Corrections adopted the building standards for inclusion in the California Building Standards Code, Title 24, California Code of Regulations. CBSC will consider the state adopting agency's written analysis justifying the approval pursuant to Health and Safety Code Section 18930, and hear public comments. Upon approval, these building standards will be codified and published into the 2022 California Building Standards Code, Title 24, California Code of Regulations.

Agenda Items 8 through 24 – State Proposing Agency Rulemakings for the 2022 Intervening Code Adoption Cycle: CBSC will take action to approve, disapprove, return for further study, or approve as amended the proposed code changes to various parts contained in the California Building Standards Code, Title 24, California Code of Regulations. CBSC action will be guided by the nine-point criteria established in Health and Safety Code Section 18930. CBSC will consider each agency's proposed building standards and its justifications, Code Advisory Committee recommendations, comments submitted during public comment period(s), and oral or written comments received at this meeting. The public may comment on any Code Advisory Committee recommendations or challenges to the proposals submitted during the comment periods. No new issues or new information challenging the proposed changes may be presented to CBSC in the adoption of the proposed regulations.
