

**INITIAL STATEMENT OF REASONS
FOR PROPOSED BUILDING STANDARDS
OF THE STATE FIRE MARSHAL
REGARDING THE 2025 CALIFORNIA WILDLAND-URBAN INTERFACE CODE,
CALIFORNIA CODE OF REGULATIONS, TITLE 24, PART 7
(SFM 08/24)**

The Administrative Procedure Act (APA) requires that an Initial Statement of Reasons be available to the public upon request when rulemaking action is being undertaken. The following information required by the APA pertains to this particular rulemaking action:

STATEMENT OF SPECIFIC PURPOSE, PROBLEM, RATIONALE and BENEFITS

Government Code Section 11346.2(b)(1) requires a statement of specific purpose of each adoption, amendment, or repeal and the problem the agency intends to address and the rationale for the determination by the agency that each adoption, amendment, or repeal is reasonably necessary to carry out the purpose and address the problem for which it is proposed. The statement shall enumerate the benefits anticipated from the regulatory action, including the benefits or goals provided in the authorizing statute.

The purpose of these proposed regulatory actions is to adopt by reference the 2024 edition of the International Wildland-Urban Interface Code (IWUIC), with California amendments, into the currently vacant California Code of Regulations (CCR), Title 24, California Building Standards Code (CBSC), Part 7 with the title of the “California Wildland-Urban Interface Code” (CWUIC).

The proposed code changes will provide a single location for all wildland laws and regulations. Currently, the regulations are in several different locations including CCR Title 24 (CBSC), Part 2 California Building Code (CBC), Chapter 7A, Part 2.5 California Residential Code (CRC), Chapter 3, Section R337, Part 9 California Fire Code (CFC), Chapter 49, CCR, Title 14, Natural Resources Code (T-14) and CCR, Title 19, Public Safety Code (T-19); as well as the California state laws including the Public Resources Code (PRC), Government Code (GOV), and Health and Safety Code (HSC). By having all wildland laws and regulations in a single location, designers, contractors, homeowners, and Authorities Having Jurisdiction (AHJ) will have a one-stop shop to find the laws and regulations they need for enforcement.

The IWUIC framework is constructed of chapters covering different topics that address specific topics in the wildland environment.

- Chapter 1 contains administrative provisions. Consistent with other parts of the CBSC, Chapter 1 is proposed to consist of two divisions. Chapter 1, Division I will detail the California state agency's identifiable administrative provisions. Chapter 1, Division II will contain specific adopted sections like other parts of the CBSC.
- Chapter 2 contains definitions and will incorporate specific definitions used throughout the document consistent with the current CBSC regulations and state laws as appropriate.
- Chapter 3 addresses wildland-urban interface areas. This section is amended to refer to how California establishes fire hazard severity zones.

- Chapter 4 establishes the access, water supply, and fire protection plan requirements based on designated fire hazard severity zones. The California version of this chapter will incorporate sections from the CBSC, Part 9 CFC, Chapters 5 and 49 as well as requirements found in the PRC, T-14, and other statutes and regulations found in California.
- Chapter 5 contains the construction requirements for new buildings constructed in designated fire hazard severity zones. This proposed Part 7 CWUIC will relocate all of the current requirements found in CBSC, Part 2 CBC, Chapter 7A, and Part 2.5 CRC, Chapter 3, section R337 into Chapter 5.
- Chapter 6 contains requirements for the establishment and maintenance of defensible space, and other items needed to protect structures in the wildland-urban interface areas. It is amended to relocate current provisions that are in CBSC, Part 9 CFC.
- Chapter 7 is the referenced standards of the IWUIC and will be amended to incorporate all relevant referenced standards found within the regulations of the document.
- Two appendices are added to the CWUIC to assist local agencies. Appendix D is a model adoption ordinance for designation of fire hazard severity zone with the local responsibility area (LRA). Appendix G contains home hardening recommendations for existing structures.

The proposal to create a Part 7 California Wildland-Urban Interface Code (CWUIC) will be an improvement for the challenges faced by designers, contractors, homeowners, and Authorities Having Jurisdiction (AHJ). This single document sets California apart as the leader and innovator in establishing solutions faced in the wildland-built environment. Consolidating the laws and regulations into this single document creates a functional tool that will facilitate the robust construction and maintenance of buildings in California's wildland-urban interface area.

CROSS REFERENCE TOOL identifies each section in the California Wildland-Urban Interface Code and identifies the source document and section for the provisions. Some sections in this code are derived from more than one source and the language has been editorially massaged to coalesce and correlate with the other provisions in this code.

The proposal to relocate regulations does not have a regulatory effect. Items that have a proposed change to regulatory effect are in items listed below.

ITEM 1

Chapter 1 Division I California Administration

SFM proposes to adopt California amendments listed below to create Division I in Chapter 1 of the 2025 California Wildland-Urban Interface Code (CWUIC), California Code of Regulations (CCR), Title 24, Part 7. The amendments are based on current statutes and regulatory language.

The importance of having clear and understandable codes is of the utmost importance and will allow the user to apply the provisions properly.

ITEM 1-1

Division I California Administration, Section 1.1 General, Sections 1.1.7 through 1.11.11

SFM proposes to copy Sections 1.1.1 through 1.1.5 of Title 24, Parts 2 and 9 to Part 7, Division I and adopt them with modifications shown below.

Section 1.1.1 Title.

The Title section establishes the Title of the regulations as Part 7 of Title 24, California Building Standards Code as the California Wildland-Urban Interface Code.

Section 1.1.2 Purpose.

The purpose of this code is to establish minimum requirements to reduce the likelihood of life and property loss due to a wildfire through the use of performance and prescriptive requirements for construction and development in all Fire Hazard Severity Zones in State Responsibility Areas (SRA), and Local Responsibility Areas (LRA) designated as a Very High Fire Hazard Severity Zone, and increase the ability of buildings located in any Fire Hazard Severity Zone within State Responsibility Areas (SRA), or Wildland-Urban Interface (WUI) Areas, to resist the intrusion of flames or burning embers projected by a vegetation fire and contributes to a systematic reduction in conflagration losses and reduce the likelihood of life and property loss due to a wildfire.

Section 1.1.3 Scope

The scope establishes where and when the regulations shall apply.

Some of these provisions are reprinted from Title 14 and are not adoptable as building standards but must be included for a complete package to protect and regulate the inhabitants and facilities in wildland interface areas.

The SFM did not rely on any technical, theoretical, or empirical study, report, or similar documents outside of those contained in this rulemaking in proposing that CBSC adopt said model code as a reference standard for the placement of existing SFM regulatory amendments for the California Building Standards Codes.

STATEMENT OF JUSTIFICATION FOR PRESCRIPTIVE STANDARDS

Government Code Section 11346.2(b)(1) requires a statement of why an agency believes any mandates for specific technologies or equipment or prescriptive standards are required.

The SFM believes that the proposed amendments to the model code and additional building and safety standards are offered in both a prescriptive and performance base. The nature and format of the model code adopted by reference allow for both methods, the following is a general overview of the model code proposed to be adopted by reference as well as state modifications:

This comprehensive wildland-urban interface code establishes minimum regulations for fire prevention using prescriptive and performance-related provisions. It is founded on broad-based principles that make possible the use of new materials and new system designs.

This code is founded on principles intended to establish provisions consistent with the scope of a building and fire code that adequately protects public health, safety, and welfare; provisions that do not unnecessarily increase construction costs; provisions that do not restrict the use of new materials, products or methods of construction; and provisions that do not give preferential treatment to types or classes of materials, products or methods of construction.

The International Wildland-Urban Interface Code (IWUIC) provisions provide many benefits, among which the model code development process offers an international forum for building and fire safety professionals to discuss performance and prescriptive code requirements. This forum provides an excellent arena to debate proposed revisions. This model code also encourages international consistency in the application of provisions. The framework of the model code has been accepted as the format that is most user-friendly and conforms to the organization of the other parts of Title 24.

CONSIDERATION OF REASONABLE ALTERNATIVES

Government Code Section 11346.2(b)(4)(A) requires a description of reasonable alternatives to the regulation and the agency's reasons for rejecting those alternatives. In the case of a regulation that would mandate the use of specific technologies or equipment or prescribe specific actions or procedures, the imposition of performance standards shall be considered as an alternative. It is not the intent of this paragraph to require the agency to construct alternatives or describe unreasonable alternatives artificially.

The SFM has determined that no alternative considered would be more effective in carrying out the purpose for which the regulation is proposed or would be as effective and less burdensome to affected private persons than the proposed adoption by reference to SFM amendments. Therefore, there are no alternatives available to the SFM regarding the proposed adoption of this code.

REASONABLE ALTERNATIVES THE AGENCY HAS IDENTIFIED THAT WOULD LESSEN ANY ADVERSE IMPACT ON SMALL BUSINESS

Government Code Section 11346.2(b)(4)(B) requires a description of any reasonable alternatives that have been identified or that have otherwise been identified and brought to the attention of the agency that would lessen any adverse impact on small business.

The SFM has determined that no alternative considered would be more effective in carrying out the purpose for which the regulation is proposed or would be as effective and less burdensome to affected small businesses than the proposed adoption by reference to SFM amendments. Therefore, there are no alternatives available to the SFM regarding the proposed adoption of this code.

FACTS, EVIDENCE, DOCUMENTS, TESTIMONY, OR OTHER EVIDENCE OF NO SIGNIFICANT ADVERSE ECONOMIC IMPACT ON BUSINESS

Government Code Section 11346.2(b)(5)(A) requires the facts, evidence, documents, testimony, or other evidence on which the agency relies to support an initial determination that the action will not have a significant adverse economic impact on business.

The SFM has determined that this proposed action will not have a significant adverse economic impact on business. The SFM affirms that this rulemaking action complies specifically with the mandates of HSC Sections 13143, 18928, 18949.2(b), 18949(c) and the mandates of the statutory authority of the SFM. Numerous public workshops were held during the per-rulemaking phase of the intervening code cycle and no comments have been made that the proposed changes would have significant statewide adverse economic impact on businesses.

Therefore, the SFM has determined that there are minimal facts, evidence, documents, testimony, or other evidence upon which the agency relied to support its initial determination of no effect according to Government Code Section 11346.2(b)(5)(A). The public is welcome to submit any information, facts, or documents either supporting SFM's initial determination or finding to the contrary.

ASSESSMENT OF EFFECT OF REGULATIONS UPON JOBS AND BUSINESS EXPANSION, ELIMINATION OR CREATION

Government Code Sections 11346.2(b)(2) and 11346.3(b)(1)

The State Fire Marshal has assessed whether and to what extent this proposal will affect the following:

- A. The creation or elimination of jobs within the State of California.**

ESTIMATED COST OF COMPLIANCE, ESTIMATED POTENTIAL BENEFITS, AND RELATED ASSUMPTIONS USED FOR BUILDING STANDARDS

Government Code Section 11346.2(b)(5)(B)(i) states if a proposed regulation is a building standard, the initial statement of reasons shall include the estimated cost of compliance, the estimated potential benefits, and the related assumptions used to determine the estimates.

The SFM does not anticipate any increase in the cost of compliance with the proposed building standards.

DUPLICATION OR CONFLICTS WITH FEDERAL REGULATIONS

Government Code Section 11346.2(b)(6) requires a department, board, or commission within the Environmental Protection Agency, the Resources Agency, or the Office of the State Fire Marshal to describe its efforts, in connection with a proposed rulemaking action, to avoid unnecessary duplication or conflicts with federal regulations contained in the Code of Federal Regulations addressing the same issues. These agencies may adopt regulations different from these federal regulations upon a finding of one or more of the following justifications: (A) The differing state regulations are authorized by law and/or (B) The cost of differing state regulations is justified by the benefit to human health, public safety, public welfare, or the environment.

The SFM has determined that this proposed rulemaking action does not unnecessarily duplicate or conflict with federal regulations contained in the Code of Federal Regulations that address the same issues as this proposed rulemaking.
