# CALIFORNIA BUILDING STANDARDS COMMISSION MEETING MINUTES April 16, 2024

## Tuesday, April 16, 2024

## Agenda Item 1. CALL TO ORDER

Chair Miriam Ingenito called the meeting of the California Building Standards Commission (CBSC) to order at 1:30 p.m. This meeting held in-person and remotely, and CBSC had a physical location listed below:

CBSC Chair Miriam Ingenito led the Commission in the Pledge of Allegiance. Acting Executive Director Kevin Day gave meeting instructions regarding teleconferencing and closed session.

#### Agenda Item 2. Commissioner re-appointments

Chair Miriam Ingenito stated that Governor Gavin Newsom reappointed Commissioners Raj Patel, Peter Santillan and Frank Ramirez to a four-year term.

Commissioner Patel is a building official with JAS Pacific, a municipal engineering and consulting service. Raj has been active in public service since 1985. He has served on

local, state, and national committees and boards, and as president of the California Building Officials.

Commissioner Peter Santillan is a secretary-treasurer of the Southern California District Council of Laborers. He has also been a business manager and a secretary-treasurer for Laborers' International Union of North America, Local 1309 since 2014.

Commissioner Frank Ramirez retired from Governor Newsom's Office of Business and Economic Development (GO-Biz) in 2021 where he held the position of deputy director of goods movement and sustainable freight.

Chair Ingenito congratulated the 3 re-appointed commissioners.

Agenda Item 3. Comments from the public on issues not on this agenda CBSC received comments from the public on matters not on the agenda.

Michael Malinowski representing AIA California and design professional members of the American Institute of Architects. He commented on CBSC under the leadership of Mia Marvelli and Kevin Day, and DSA under the leadership of Ida Clair and the work of many stakeholder organizations and subject matter experts from across the country that launched the CalGreen Carbon Reduction Collaborative, which created for the first time a point of intersection between California's climate objectives, best practices and current information on sources and potential control of greenhouse gas emissions. First in the nation, CalGreen entity has a formal charter, a long list of participants that have signed on to the charter.

Chair of the Code Adoption Committee, Raj Patel gave an overview of the Code Adoption Committee meeting held that morning regarding the State Fire Marshal (SFM) proposal to adopt the 2024 International Wildland-Urban Interface Code (IWUIC) using it as a framework to relocate and consolidate existing wildland-urban interface regulations into the California Wildland-Urban Interface Code (Part 7, Title 24, California Code of Regulations—currently vacant).

## Agenda Item 7. CBSC Strategic Plan Update

Staff provided the commissioners with an overview of the forthcoming update to the CBSC Strategic Plan.

Laura Mills, Associate Governmental Program Analyst with the Building Standards Commission gave an overview. She joined CBSC in 2017 and explained her duties as an Education and Outreach Coordinator. She presented the CBSC Strategic Plan update proposal and asked the commissioners for volunteers to review the updated proposal.
