

**NOTICE OF 45-DAY PUBLIC COMMENT PERIOD FOR  
PROPOSED BUILDING STANDARDS FOR THE  
CALIFORNIA BUILDING STANDARDS CODE, TITLE 24  
of the CALIFORNIA CODE OF REGULATIONS

The California Building Standards Commission (CBSC), on behalf of the Division of the State Architect and Department of Housing and Community Development, is providing notice of code changes intended for the 2025 California Building Standards Code.

CBSC will accept written comments for at least 45 days between **July 26 and September 9, 2024**. All written comments for this period must be submitted no later than midnight on **September 9, 2024**.
