

**NOTICE OF ADDITIONAL 15-DAY PUBLIC COMMENT PERIOD FOR
PROPOSED BUILDING STANDARDS FOR THE
CALIFORNIA BUILDING STANDARDS CODE, TITLE 24
of the CALIFORNIA CODE OF REGULATIONS
DIVISION OF THE STATE ARCHITECT, OFFICE OF STATEWIDE HOSPITAL
PLANNING AND DEVELOPMENT, and the STATE FIRE MARSHAL**

The California Building Standards Commission (CBSC), on behalf of the Division of the State Architect, Office of Statewide Hospital Planning and Development, and the State Fire Marshal, is providing notice of code changes intended for the 2025 California Building Standards Code, which were the subject of written comments from the initial 45-day public comment period that began on September 6, 2024, and ended on October 21, 2024.

CBSC will accept written comments for at least 15 days between **November 6 and November 21, 2024**. All written comments must be submitted to CBSC no later than midnight on **November 21, 2024**.
