

**NOTICE OF ADDITIONAL 15-DAY PUBLIC COMMENT PERIOD FOR
PROPOSED BUILDING STANDARDS FOR THE
CALIFORNIA BUILDING STANDARDS CODE, TITLE 24
of the CALIFORNIA CODE OF REGULATIONS
CALIFORNIA BUILDING STANDARDS COMMISSION and OFFICE OF STATEWIDE

The California Building Standards Commission (CBSC), on its own behalf and that of the Office of Statewide Hospital Planning and Development, is providing notice of code changes intended for the 2025 California Building Standards Code, which were the subject of written comments from the initial 45-day public comment period that began on May 17, 2024, and ended on July 1, 2024.

CBSC will accept written comments for at least 15 days between **July 29 and August 13, 2024**. All written comments must be submitted to CBSC no later than midnight on **August 13, 2024**.
