Rare Disease Day | February 28, 2025



Rare Disease Day is celebrated every February 28, or February 29 during a leap year because it is the rarest day of the year. Rare Disease Day is an annual global event that raises awareness of the challenges faced by individuals living with rare diseases. In California, there are over 3 million people affected by a rare disease. This large population has unique challenges that can make everyday activities more difficult. To address this, California has started to create a Rare Disease Advisory Council (RDAC) to help policymakers understand the needs of individuals with rare diseases. Living with a rare disease can impact the experience of visiting businesses. Business owners and operators can

play a key role in improving these experiences by creating an accessible environment to better accommodate customers with disabilities. This can include physical accommodations as well as training staff to better understand the needs of customers with disabilities. Raising awareness of Rare Disease Day can help create a more inclusive community for all.

Cutting Edge Assistive Technology - TanvasTouch

Tanvas is a company in California that makes technology to help people feel textures on touchscreens. Haptic technology refers to systems that create tactile sensations, such as vibrations or textures that can allow users to "feel" digital content. Tanvas adds a new way for people to use digital screens by creating tactile sensations on smooth touchscreens. A traditional touchscreen can mainly provide visual or sound feedback, but TanvasTouch creates a way for users to feel textures and responses with their fingers. This cutting-edge assistive technology tool can help simplify navigation for individuals with disabilities. Businesses can benefit from using haptic technology to help enhance customers with disabilities experience while in their store. For example, restaurants can use haptic feedback in their digital menus to assist customers with disabilities in identifying menu items, special offers, or even allergy information through touch. Tanvas is developing haptic technology that can help enhance how individuals with disabilities interact with digital devices. By incorporating tactile feedback into touchscreens, businesses can help support customers with disabilities. This technology allows easier navigation and access to information that can help to create a more inclusive environment for everyone.
