WOOD STRUCTURAL PANEL ACCEPTANCE—PLYWOOD AND ORIENTED STRAND BOARD (OSB): 2022 CBC

PURPOSE

This Interpretation of Regulations (IR) clarifies the requirements for approved testing and inspection agencies that are able to provide panel marks indicating conformance of plywood and oriented strand board (OSB) to the applicable standard.

SCOPE

This IR is applicable to plywood and OSB, used structurally, and required to meet the panel marking requirements of the California Building Code (CBC), Section 2303.1.5 indicating conformance to the applicable standard.

BACKGROUND

The CBC requires that each wood structural use panel used structurally be identified by the trademarks of the approved testing and inspection agency that has identified the panel in conformance with the requirements of the applicable standard, either Department of Commerce (DOC) Voluntary Product Standard (PS) 1 Structural Plywood or DOC PS 2 Performance Standard for Wood Structural Panels, applicable to both plywood and OSB. Prior versions of DOC PS 1 and DOC PS 2 provided a very broad definition for a qualified inspection and testing agency without any specific reference to national standards. DSA added specific requirements and references to national standards in previous versions of this IR to help stakeholders identify an approved testing and inspection agency. The current versions of DOC PS 1 and DOC PS 2 now incorporate national standard references. While the requirements for a qualified testing and inspection agency to provide panel markings are now clarified, determining whether a testing and inspection agency meets those requirements can still be time-consuming and difficult.

1. PANEL MARKING

Panel marking shall comply with DOC PS 1 Section 7 for plywood or DOC PS 2 Section 8 for plywood or OSB. Each panel shall bear markings identifying the qualified testing and inspection agency (per Section 2 below) in addition to the other panel marking requirements of the respective identified applicable standard and the CBC.

2. APPROVED TESTING AND INSPECTION AGENCY

Appendix A provides a list of approved testing and inspection agencies. Testing and inspection agencies are considered approved by DSA if they meet all of the following:

2.1 Accredited by an independent, nationally recognized accreditation body to be both a testing laboratory and an inspection agency. International Accreditation Service [IAS] and ANSI National Accreditation Board [ANAB] are accreditation agencies that DSA currently recognizes. Other nationally recognized accreditation agencies may be accepted by DSA with prior approval.

2.2 The scope of accreditation shall specifically identify the testing and inspection of wood structural panels to the requirements of DOC PS 1 (plywood) or DOC PS 2 (plywood or OSB). Where a more recent version of DOC PS 1 or DOC PS 2 is being used and complied with, and there is not a required change to manufacturing or qualification under the new standard, it is permissible to use the older markings for a period of up to one year.
