# Office of Administrative Hearings' Response to Committee Recommendations

# Agenda Item 13:

## **Recommendation:**

That Office of Administrative Hearings, known as OAH, Administrative Law Judges, referred to as ALJs, and Pro Tem mediators remind participants of the OAH ALJ/Pro Tem survey form at each mediation, and conclusion of each hearing.

## **OAH Response:**

OAH will inform ALJs and Pro Tem mediators to remind participants of the survey form at the conclusion of each mediation and hearing.

# Agenda Item 14:

## **Recommendation:**

That OAH create a policy or procedure to ensure that at prehearing conference, any accommodation or interpretation is adequate, functional, and accessible by all parties, so long as OAH is timely notified of the need for accommodation or interpretation.

## **OAH Response:**

OAH does everything in its power to make sure that the reasonable accommodations are implemented and functioning.

# **Agenda Item 15:**

#### **Recommendation:**

That OAH post on its website the entities it contracts with to provide interpreting services.

#### **OAH Response:**

OAH contracts with Interpreters Unlimited for language interpretation,
Signglasses, LLC for video conference sign language interpretation, and Hardeman
Realtime, Inc. for Communication Access Real-Time Translation, also known as CART,
services. OAH will provide copies of the contracts upon a California Public Records Act
request.

# Agenda Item 16A:

#### Recommendation:

That upon timely request from a petitioner or self-represented parent to a due process hearing, the OAH will provide an in-person mediation or due process hearing. A timely request is a request made 10 calendar days prior to the mediation or due process hearing.

## **OAH Response:**

OAH will continue to consider requests for in-person mediations and hearings on a case-by-case basis. OAH will explore the possibility of convening meetings of interested persons in Northern and Southern California with members of the special education community to discuss in person mediations and hearings, including the logistics on how any proposal for conducting in person mediations and hearings would be implemented.

#### **Recommendation:**

That upon request from a petitioner or self-represented parent of a due process hearing, OAH will provide an in-person mediation or due process hearing.
