PROPOSED REGULATIONS ON THE IMPLEMENTATION OF PROPOSITION 2 FOR THE SCHOOL FACILITY PROGRAM

To present to the State Allocation Board proposed regulations, on an emergency basis, that implement the following provisions of the Kindergarten Through Grade 12 Schools and Local Community College Public Education Facilities Modernization, Repair, and Safety Bond Act of 2024 (Proposition 2):

- Financial Hardship;
- Modernization Eligibility for Schools Located on Military Installations and New Construction Eligibility for Small School Districts; and
